**Complaint Summary**

The delays in this case have been caused 100% by the detectives and senior ranks of the South Simcoe Police Service who did not want to investigate and who have done everything possible to help the wealthy brokers of Verico the Mortgage Station who are very well connected in Simcoe County. We have, so far, been viewed by more than 500,000 mostly Ontario residents, and our following is growing. More than 97% of people who have commented on our stories and evidence have clearly shown support for our reporting on this story of defrauding seniors. This story is considered by our many followers to be one of police corruption. It is not in the best interests of the image of law enforcement in Ontario for this matter to be once again ignored or shelved, as has been done repeatedly by the detectives and senior ranks of the South Simcoe Police Service. I am currently compiling a detailed package of evidence that will be forwarded to your office. That package will also be sent to submitted to the Ontario Provincial Police (OPP) Office of Professionalism, Respect, Inclusion & Leadership, the Financial Services Regulatory Authority of Ontario (FSRA), the Office of

the Solicitor General, the Ministry Of Community Safety & Correctional Services, and the Canada Revenue Service in support of requests for investigations. Our story has been online for more than 535 days, or 18 months, and in all that time neither the brokers of Verico the Mortgage Station nor management at HomeEquity Bank have contested any of our allegations. There has been no court action seeking injunctive relief, nor even an angry letter from a lawyer. The South Simcoe Police Service have never contested our speculation that their detectives and senior ranks have been 'motivated' by the brokers at Verico the Mortgage Station to whitewash the investigation in their favour. My crew and I work as a not-for-profit media service that has donated more than \$700,000.00 in skilled labour and the use of production facilities to our community by providing, free of charge, at least 350 videos to more than 180 charities, not-for-profits, and benevolent community groups. Given the apparent level of 'motivation' used to sway previous investigations by the South Simcoe Police Service, and the apparent bias of the senior ranks, I believe it is in the best interests of the citizens of Simcoe County that any review not be undertaken by detectives of that department. I request that any investigation be undertaken by the Ontario Provincial Police (OPP) Office of Professionalism, Respect, Inclusion & Leadership
